YOWIE GROUP TO ACQUIRE ERNEST HILLIER CHOCOLATE MANUFACTURING BUSINESS

Yowie Group Ltd (ASX: YOW) (the "Company" or "Yowie") announces that it has entered into a binding Asset Purchase Agreement with the administrators of Chocolate and Confectionary Company Pty Limited to acquire the assets of the Ernest Hillier chocolate business for \$375,000. This is Australia's first chocolate manufacturer and oldest privately owned chocolatier, established in 1914.

The business, located in Coburg North, Victoria, has the capability to produce a large range of products from its leasehold operations (of circa 4,000 sq metres), including:

- Premium Australian chocolates, including chocolate coated scorched almonds, macadamias, liquorice, fruit & nut, choc berries and mints;
- Premium Australian crème centred chocolates, including peppermint cream, orange cream, strawberry cream, Devonshire caramel, Turkish Delight and hazelnut praline; and
- Nutritional, energy and healthy snack bars.

Yowie is acquiring all the owned plant and equipment and all the IP of Ernest Hillier, including all business names and brands of the Ernest Hillier chocolate business, and is to enter into new leases for the premises and obtaining either new leases or assignments in respect of leased plant and equipment used by Ernest Hillier. Yowie is not assuming any of the existing liabilities of the sellers.

Yowie Group Chairman, Sean Taylor, said: *"The Ernest Hillier acquisition represents an important step in the evolution of our business. It enables us to preserve an iconic Australian chocolate manufacturing business with significant heritage value and capability, and in doing so take greater control over our future. When the current Board were appointed, Yowie was a one SKU business, concentrated on the US market. Since then, the Yowie product has returned to Australian stores, and we have expanded our product offerings through a range of seasonal Christmas and Easter products and more recently the collaborations with [AFL/NRL/Bluey etc]. Today, the addition of the Ernest Hillier business enables us to further expand our product range of premium Australian chocolates, providing greater control over the production of our products and we are excited about the future potential that this acquisition provides."*
